Business Manager, Ms D Boyce	Questions about payments of fees, subject contributions, excursions, camps, EMA, incursions and other events.
School Council	Concerns, comments, feedback regarding school policies.
Careers Advisor, Ms A Chantry	Advice on career paths, tertiary courses, TAFE courses, subject selection in Year 12, VTAC advice.
